- 1. Elect Betsy Colon to fill the board seat vacated by Tamara Kenney
 Lee made a motion to elect Betsy Colon by unanimous consent, Kallio seconded, carried.
- 2. Affirm Executive Committee approval of Livingston CARES to accept funds from the Community Resource Network (CRN has \$777.11 balance in their account) and to establish a project account for the CRN.

Motion made by Freeman, Bailey seconded, carried.

- 3. Affirm Executive Committee approval to move forward on planned 2019 planned trips See list above. Motion to proceed with planning for trips made by Natoli, seconded Harvey, carried.
- 4. Affirm Executive Committee approval to Authorize Board President and Treasurer to investment of funds into CDs \$20,000

2 CDs at \$10,000 with 2% rate

Discussion: Lyle asked if we should check with bank if there are other, more flexible options. Matthews noted that we should talk to RACF at some point

A motion to invest \$20,000 of our unrestricted funds into a more advantageous account with a higher rate of return. Motion made by Natoli, seconded by Lehman, carried.

5. Approve the appointment of Nicholas Palumbo as Vice Chair of Livingston County CARES, Inc.

Discussion: Lee intends to vote no: Referring to bylaws (Art. IV. C. 3) it is his interpretation that we cannot elect a executive member as the position is not vacant (it was never filled). Lee emphasized his NO vote is not a vote against Nick, but the procedure and reading of the bylaws.

Motion to approve the appointment made by Lehman, seconded by Kallio. 1 No Vote: Lee. Motion carried.

- 6. Affirm Executive committee approval to establish <u>no fee</u> structure for membership to Livingston County CARES, INC. effective immediately. Motion made by Freeman, seconded by Natoli, carried.
- 7. Approve a resolution to officially thank and recognize Tamara Kenney's board membership and contributions to the work of Livingston CARES, Inc. Motion made by Lee to accept Kenney's resignation with recognition, thanks, and appreciation for her years of service to the Livingston County CARES, Inc. board. Seconded by Kallio, carried.
