- There is no age or length of service requirement for the CARES AWARD, but the service must be voluntary and unpaid.
- Eligible recipient of The CARES AWARD must either live or work in Livingston County.
- Eligible recipient of The CARES AWARD volunteer work must benefit the community of Livingston County.
- Individuals, organizations or groups (profit or non-profit) can be nominated for the CARES AWARD by community members, employers, or educational institutions (faculty, staff, or students.)
- Individuals can also nominate themselves for the CARES AWARD.

**The deadline to submit a nomination is Friday, February 6, 2026 at 11:59 PM.**


